



### AGREEMENT ON ACADEMIC EXCHANGE BETWEEN

## NATIONAL INSTITUTE OF TECHNOLOGY (KOSEN), HAKODATE COLLEGE (JAPAN)

#### AND

# PRINCESS CHULABHORN SCIENCE HIGH SCHOOL CHONBURI (THAILAND)

National Institute of Technology (KOSEN), Hakodate College (Japan) and Princess Chulabhorn Science High School Chonburi (Thailand) (hereinafter individually referred to as a "Participant" and collectively referred to as the "Participants"), in order to promote academic exchange and cooperative education and research, hereby conclude the following Agreement on Academic Exchange (hereinafter referred to as "Agreement").

- Article 1. The Participants agree to implement exchange and the following activities in areas of education and research of mutual benefit. The program specifications such as the number of participating students/teachers/staffs/researchers, durations, and the contents of the program will be determined through mutual consultations between the Participants.
  - 1) Exchange of students
  - 2) Exchange of teachers, academic staff, administrative staff and researchers
  - 3) Exchange of academic materials, publications and information
  - 4) Joint research and symposia
- Article 2. Selection procedures for programs are as follows.
  - 1) The Participant to send students/teachers/staffs/researchers will be responsible for its nominees' selection.
  - 2) A sufficient command of English will be required of all nominees.

### Article 3. Funding

- 1) Costs of the cooperative activities undertaken under this Agreement shall be funded on a reciprocal basis.
- 2) Tuition shall be mutually exempted for all exchange students.

- 3) Accommodation, meals, land transportation and hospitality for the Participants' representatives during the entire stay will be provided by the host Participant. The international air fare will be borne by the visiting Participant.
- 4) Cost of medical care for major accident or illness shall be covered by international travel insurance premium, which shall be arranged by the visiting Participant or individual students/teachers/staffs/researchers before leaving the country.
- 5) The specifications shall be determined through mutual consultations between Participants as necessary.

Article 4. Upon signing from both parties, this Agreement will be valid from March 9<sup>th</sup>, 2023 to March 8<sup>th</sup>, 2028. This Agreement may be renewed for a further period of five (5) years by mutual agreement prior to the date of expiry.

Article 5. This Agreement may be amended by mutual agreement.

Article 6. This Agreement may be terminated at the request of either Participant, in which case ninety (90) days' notice must be given.

Article 7. This Agreement is created in duplicate in English, each of those duplicates being deemed original.
